DAY 1: ARRIVE DETROIT

DAY 3: DEARBORN - MACKINAC ISLAND

Enjoy this small city settled by Germans from the Bavarian region. The streets are lined with Bavarian style shops including Bronner's Christmas Wonderland and Frankenmuth Riverplace.

DAY 6: FRANKENMUTH - NIAGARA FALLS

Motorcoach into Ontario, Canada*, and drive east to Niagara Falls, one of the natural wonders of the world. Stop to see the IMAX movie: Niagara: Miracles, Myths & Magic. Later enjoy the unique "Journey Behind the Falls" experience where you descend 125 feet and explore 130-year-old tunnels carved through the bedrock. Feel the thunderous vibration of the Horseshoe Falls before arriving at the observation deck for an up close and possibly wet view of the falls. Later check into your hotel for two nights in Niagara Falls.
